A regular meeting of the **PUBLIC SAFETY COMMITTEE** was held tonight, Commissioner J. Andrew Sharkey Chairman, presiding. Members present were Commissioners McKeown (via telephone), Norris, and Rappoport. Also present was Ex-Officio Member Portner.

Staff present were John J. Norris, Chief of Police; Kevin O'Brien, Deputy Chief of Police; Joseph O'Neill, Fire Marshal; Henry Sekawungu, Director of Planning/Zoning, and Bryan T. Havir, Township Manager. Also present was Joseph Bagley, Esq., Solicitor. A Public Attendance List is attached.

Mr. Sharkey called the meeting to order at 7:30 p.m. and announced that prior to the meeting, the Commissioners held an Executive Session to discuss pending litigation and real estate matters. He complimented the Police, Fire, and Emergency Services and Emergency Management Departments for their outstanding response to a recent incident at the La Mott Fire Company.

1. Under Report of the Police Chief, Chief Norris reported the following:
  - a. He reviewed the Police Activity/Community Policing Unit, Clearance and Juvenile Contact Reports for the month of February, 2015.
  - b. He recommended the following amendments to the Traffic Code, which were approved by Staff:

Add: Lycoming Avenue (this street is not in the Code)  
Lycoming Avenue, Stop Street at Glenwood Road and at Lenape Avenue.  
Delete: Crest Avenue, Handicap Parking, south side, 30-feet east of Oak Avenue to 50-feet east of Oak Avenue.

**Recommendation to the Board of Commissioners:** Upon motion of Mr. Portner, the Committee unanimously recommended to the Board of Commissioners the adoption of an Ordinance amending Chapter 285 of the Traffic Code entitled "Vehicles and Traffic" (see attached).

Upon motion of Mr. Portner, the Committee unanimously accepted the Police Activity/Community Policing Unit, Clearance and Juvenile Contact Reports for the month of February, 2015.

2. Mr. Norris asked when the La Mott Fire Company would return to service. Mr. O'Neill responded that it is currently regrouping and should be at full service on Thursday morning, April 2, 2015.

3. Upon motion of Mr. Portner, the Committee unanimously accepted the Report of the EMS Director for the month of February, 2015.

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF CHELTENHAM, CHAPTER 285 THEREOF, ENTITLED VEHICLES AND TRAFFIC, BY AMENDING CERTAIN STREET AND PARKING REGULATIONS.

The Board of Commissioners of the Township of Cheltenham hereby ordains:

**SECTION 1.** The Code of the Township of Cheltenham, Chapter 285, Article IV, entitled Schedule of Traffic Regulations, Section 285-43 thereof is hereby amended by **ADDING** the following:

LYCOMING AVENUE

**SECTION 2.** The Code of the Township of Cheltenham, Chapter 285, Article IV, entitled Schedule of Traffic Regulations, Section 285-43 thereof is hereby amended by **ADDING** the following:

LYCOMING AVENUE           (1)     STOP STREET at Glenwood Road; at Lenape Avenue

**SECTION 3.** The Code of the Township of Cheltenham, Chapter 285, Article IV, entitled Schedule of Traffic Regulations, Section 285-43 thereof is hereby amended by **DELETING** the following:

CREST AVENUE           (7)     HANDICAPPED PARKING, south side, 30 feet east of Oak Avenue to 50 feet east of Oak Avenue. This addition is effective for the duration period that this resident is eligible for a reserved handicapped parking sapce.

**SECTION 4.** That in all other respects Chapter 285 of the Code of the Township of Cheltenham is hereby approved and accepted as amended, and shall continue in full force and effect.

**SECTION 5.** This Ordinance shall take effect and be in force from and after its approval as required by law.
