1. **Meeting Commencement-** Chairman Wieck called the meeting to order at 7:15 P.M.
2. **Meeting Minutes-** The minutes of the May 21, 2020 meeting were accepted by those present.
3. **Old Business**

- a. Application W20-249 of Joseph Waggoner, for 139 Woodland Road, Wyncote, PA 19095

Mr. Waggoner was in attendance on the call to further discuss his application regarding the proposed choice of spindles and railing style which had been tabled from the last meeting. Sample pictures of his proposed choices were provided. It was determined to be appropriate for the rest of the porch.

Application W20-249 of Joseph Waggoner, for a property located at 139 Woodland Road, Wyncote, PA 19095 for the 3" x 3" Vintage Style replacement spindles and the 2" x 4" "molded" was recommended to the Public Works Committee for a Certificate of Appropriateness.
