A regular meeting of the **PUBLIC SAFETY COMMITTEE** was held tonight, Harvey Portner, Chairman, presiding. Members present were Commissioners McKeown, Sharkey, Simon and Swavola. Also present was Ex-Officio Member Greenwald. Staff present were Bryan T. Havir, Assistant Township Manager; David M. Lynch, Director of Engineering, Zoning & Inspections; John J. Norris, Chief of Police; Kevin O'Brien, Deputy Chief of Police; Joseph O'Neill, Fire Marshal; Ruth Littner Shaw, Main Street Manager; and David G. Kraynik, Township Manager. A Public Attendance List is attached.

Mr. Portner called the meeting to order.

1. Chief Norris reviewed the Police Activity/Community Policing Unit, Clearance and Juvenile Contact Reports for the month of June, 2009.

2. Chief Norris reviewed a proposed Ordinance amending the Traffic Code as follows:

DELETE:

GREEN LANE STOP STREET at Dell Lane.

ADD:

GREEN LANE STOP STREET at Church Road; at Dell Lane;
at Washington Lane.

GLEN OAK ROAD STOP STREET at Widener Road.

RAMBLER ROAD STOP STREET at Spring Avenue; at Whitewood Road.

WILLOW AVENUE No Parking, southerly side, Cedar Lane to 50 ft. east.

WILLOW AVENUE No Parking, southerly side, Cedar Lane to 70 ft. west.

Chief Norris advised that the Green Lane signage is installed but is not in the Code. The Willow Avenue changes are due to site distance issues and the Glen Oak Road and Rambler Road Stop Streets are due to these being uncontrolled intersections.

3. Upon motion of Mr. McKeown, and unanimously approved by the Committee, it is recommended to the Board of Commissioners the adoption of an ordinance amending Chapter 285 thereof, entitled "Vehicles and Traffic" (see attachment).

4. Upon motion of Mr. Greenwald, unanimously approved by the Committee, the Police Activity/Community Policing Unit, Clearance and Juvenile Contact Reports for the month of June, 2009, were accepted.

5. Upon motion of Mr. Greenwald, and unanimously approved by the Committee, the Report of the Fire Marshal for the month of July, 2009 was accepted.

6. Upon motion of Mr. Simon, and unanimously approved by the Committee, the Report of the EMS Director for the month of June, 2009 was accepted.

7. Under Citizens Forum: Kathy Bowers, 415 Paxson Avenue, stated that she is employed at a business on Easton Road where there is two-hour meter parking. She and other employees get tickets, and it is difficult for them to keep the meters filled when they get busy with customers. She was told that the meters were installed at the request of businesses that complained employees were parking all day and customers could not get parking spaces. The Police Department was asked to contact Ms. Bowers to seek a possible resolution to the matter.

There being no further business, upon motion of Mr. Greenwald, and unanimously approved by the Committee, the meeting was adjourned.
